## **PROJECT SYNOPSIS**

The National Council of Negro Women (NCNW) is conducting an outreach campaign to acquaint residents of Mississippi with the availability and benefits of the Affordable Connectivity Program (ACP). The ACP is a program under the Federal Communications Commission to help provide affordable broadband services and devices and most persons receiving assistance through social programs such as Medicaid, SNAP, WIC and so on are eligible for the benefit. The program initially launched in December 2021.

NCNW is a national civil and human rights organization, based in Washington, DC, with members and local sections in the state of Mississippi. NCNW was founded by the renowned educator and civil rights activist Dr. Mary McLeod Bethune in 1935. Today, Rev. Shavon Arline-Bradley is President and CEO of NCNW. NCNW has more than 300 sections (chapters) across the US and leads a coalition of 33 national women's groups. # **POSITION SUMMARY**

ACP Project Manager Job Description

The ACP Project manager will be the key to successful completion of NCNW's FCC Mississippi Affordable Connectivity Project. The Project Manager is responsible for implementing project goals, delivering outputs and creating positive outcomes. The Project Manager role is a full-time, onsite, two-year engagement. Daily responsibilities include aligning available resources to achieve project objectives of increasing broadband adoption and technical ability in rural Mississippi. Project manager responsibilities include managing two team leaders and numerous volunteers, achieving milestones, and communicating results to stakeholders.

Duties include: Assure that project milestones are met. Assure technical, logistical and human resource requirements are available and properly allocated to carry out the project. Engage relevant constituencies, including school systems, health providers, NCNW sections and Affiliates. Conduct a monthly virtual community of practice session to align project activity with goals and desired outcomes. Timely implementation of the project work plan. Recruit and train team leaders and volunteers. Track staff and volunteer hours and compensation. Secure services of a trained ACP navigator. Track and document all project expenditures. Provide monthly program and finance reports to NCNW headquarters. Plan and execute community engagement activities across the 22county footprint of the ACP project. (We may scale this back to 15 counties) Serve as the community relations point of contact for the ACP project. Tabulate and report project outputs. Maintain accurate records of project activity. Assure project outputs are delivered on time within the stipulated scope and budget. Refine and implement the project Work Plan. Develop a detailed plan to monitor and track the progress of the project. Coordinate with internal and external parties for the flawless execution of projects. Manage relationships between clients and stakeholders. Measure project performance using appropriate project management tools. Perform risk management analysis to reduce project risks. Report and escalate to upper management as needed. Create and maintain a comprehensive project documentation
