

John Lewis Voting Rights Advancement Act (HR-4)

THE ISSUE

After the *Shelby v. Holder* Supreme Court decision that dismantled Section 4(b) of the Voting Rights Act of 1965. Voter suppression has increased nationwide with many anti-voting laws being passed. Currently there are multiple efforts nationwide to undermine voters including in the redistricting process, voter registration rules, and how people vote. Furthermore, there are current efforts to prevent private organizations from being able to sue state governments for anti-voter laws. With the claim that civil rights organizations have no right to take these cases to court. The John Lewis Voting Rights Advancement Act not only reaffirms the protections that were taken out of the Voting Rights Act of 1965, but it provides new protections for voters as well.

THE ASK

Contact your Representative and tell them that you support the introduction of this bill to the House of Representatives. July 17th is the John Lewis National Day of Action and we want to continue to champion voting rights.

THE BACKGROUND OF THE JOHN LEWIS VOTING RIGHTS ADVANCEMENT ACT

The John Lewis Voting Rights Advancement Act was introduced in the House of Representatives in 2021. During the 2020 Presidential Election the threat of COVID-19 saw many people choose to vote by mail. However, along with other anti-voting measures there were attempts to throw out these ballots with claims of voter fraud, however there was no evidence to support this. Despite these claims being disproved many people chose to continue to believe in this misinformation culminating in the January 6th assault on the Capitol to overturn the election. It became clear that more protections for voting needed to be put in place to protect our democracy. The bill originally passed in the House during the 117th Congress (2021-2022), but now needs to be reintroduced in the current 118th Congress.

THE ROLE OF AND IMPACT OF THE JOHN LEWIS VRAA



To address the voter suppression this country faces, the John Lewis Voting Rights Advancement Act restores the parts of the Voting Rights Act that were dismantled in the *Shelby v. Holder* decision. As well as, creates new protections and guidelines around voting giving more power to the Department of Justice to enforce voting protection. The John Lewis VRAA will not only protect voting rights but expand voting rights for those eligible to vote. Ensuring more security for our democratic process and that discriminatory anti-voter practices cannot continue.

THE PUSH FOR PASSAGE AND OUR ROLE AT NCNW

Voting Rights is one of the values that the National Council of Negro Women (NCNW) supports and cherishes in championing the voices of Black Women and their communities. Voting directly impacts the representation of Black families and communities in our political institutions. NCNW continues to be a vocal advocate for voting rights. The values and legacy of John Lewis are reflected in this act, these are the values of NCNW. Rep. Terri Sewell (D-AL-7) who introduced the bill in the House in the 117th Congress also shares these values.
